### ABOUT YOUR PHOTOGRAPH

*Professional photographs are frequently copyrighted. It is the advertiser's responsibility to obtain a copyright release prior to publication.*



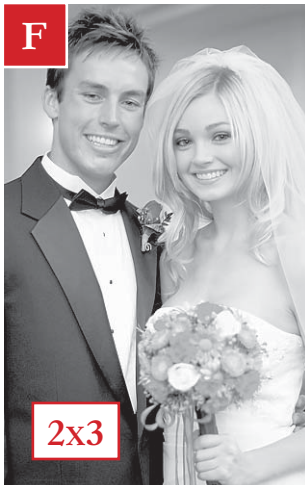
